## Parade Information & Regulations

### 1. General Rules:

All entries are encouraged to use creativity in incorporating an Olde Tyme Village Christmas theme in your entry.

Since this is a nighttime event it is mandatory that lights are featured on each float or entry.

Entries are encouraged to incorporate live or recorded seasonal music into the entry.

Entries are subject to safety inspections.

Everyday vehicles will not be allowed unless pulling a float or providing transportation for pageant entries.

No tractor trailers allowed.

Adults must supervise children on floats.

A safe number of individuals must be maintained on each float.

No **Santas** are permitted as there will be ONE pre-designated Santa.

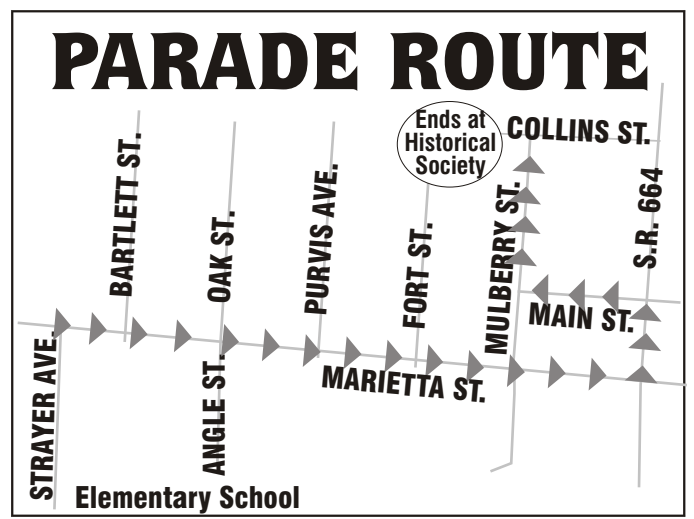
NO WALKING entries are permitted except for Bands, Military Units, and Drill Teams. They must be in uniform and holiday accessories are encouraged.

**NO CANDY THROWING IS PERMITTED.** We are requesting a \$20 donation from entrants. This money will be pooled together and Children's treat bags will be passed out by Santa at Dowling Park (downtown) after the parade and during the "Clock Lighting".

### 2. Cancellation Policy: This event is rain, snow or shine. Only a Level 2 Snow Emergency will cancel the event.

For good and valuable consideration, including permission for the undersigned to participate in the Bremen Nighttime Lighted Olde Tyme Village Christmas Parade and related activities, I the undersigned for myself, my successors, heirs, assigns, executors, and administrators;



1. Agree that prior to participation, I shall inspect the car/float and equipment to be used and certify it as safe and in working order;
2. Assume any and all risks of personal injuries to myself, including medical or hospital bills, permanent or partial disability, or death and damages to my property, real or personal, caused by or arising from my participation in this event or activity;
3. Covenant not to sue the Village of Bremen, Bremen Area Chamber of Commerce, Bremen United Methodist Church and their officials, employees, agents or volunteers;
4. I further declare that I am fully insured to operate said vehicle, float, and specifically, that I carry liability insurance to cover property damage and physical injuries to others;
5. I have carefully reviewed this agreement and fully understand its content. I am aware that I am releasing certain legal rights as I enter into this waiver. This document relieves the Village and others from liability for personal injury, wrongful death, and property damage caused by negligence. I have read this release and waiver, understanding that I have given up substantial rights by signing it and sign voluntarily.
