THE COMMITTEE ON FINANCIAL PROCESS: This committee's legislative purpose is to review, investigate, and recommend Council action in all fiscal matters relating to the Village of Bremen; including budgets, appropriations, taxes, assessments, employee wages, benefits and relations; expenditures, and general monetary policy, as well as issues pertaining to economic development and other special assignments. This committee also will oversee our Records Policy for retention and disposal of records. 2012: Toni Harper, Chair; Carl Graham, Seat 1; Debbie Wolfe, Seat 2

THE COMMITTEE ON VILLAGE SAFETY & INFRASTRUCTURE: This committee's legislative purpose is to review, investigate, and recommend Council action in all matters involving the general safety of the Village and the planning and execution of the Village streets and utilities. This includes matters concerning public buildings, personal and home safety, and civil defense; traffic safety, parking issues, traffic flow; matters relating to streets, sidewalks and alleys; matters relating to the storm and sanitary sewers, public water system; garbage and recycling collection and issues; as well as the future development of the street, water, and waste water systems and needs. This committee works with the Village Block Watch on issues of crime prevention and initiatives, as well as the general safety well being of the Village and her residents.

THE COMMITTEE ON RECREATION & FACILITIES: This committee's legislative purpose is to review, investigate, and recommend Council action in all matters of recreational facilities, beautification of public park lands, public park safety issues, swimming pool operations, and any other special assignments.

THE COMMITTEE ON ZONING ISSUES: This committee's legislative purpose is to review, investigate, and recommend Council action to modifications of the Zoning Ordinance and Zoning Maps; site development plans and Zoning amendments. In addition, this committee handles all issues of permits, recommendations from our Code Enforcer, and participates in Village planning activities. This committee handles items such as annexation and cooperative ventures with adjoining townships and land owners.

THE DESIGN AND REVIEW BOARD: This committee's legislative purpose is to review, investigate and recommend Council action and enforce legislation already in place concerning all matters of preserving and enhancing Bremen's Historical Overlay District's physical attractiveness and historic quality while allowing for reasonable growth and development. This Board developed out of the Downtown Revitalization Committee and serves as the Overlay point of contact for businesses as well as enforcement for compliance.

This Board meets the same night as the Committee On Zoning Issues AS REQUIRED.

Village residents are welcome to attend any of the meetings of the Standing Committees. If you wish to attend and share a concern for the need of a NEW LAW or the ENFORCING OF AN EXISTING LAW you are free to come and share that concern. The Committee will listen to you and then deliberate as to what to take back to Council. Unless coming from the Village Administrator or Clerk/Treasurer, all Ordinances and Resolutions come from the Standing Committees. When passed, the Ordinances and Resolutions become the law by which the Village is governed.

THE VILLAGE COUNCIL MEETING is the gathering of the elected officials along with the Village Administrator, Sheriff Deputy, and village residents who have registered to speak on a specific topic. Again, village residents are welcome to attend but to observe only. One must register with the Village Office before 3:00pm on the Friday before the Council Meeting. Usually, those speaking, will be speaking in relation to an Ordinance or Resolution that a Standing Committee is presenting. If one is not speaking in relation to Council action; they could be referred to one of the Committees or to meet with the Village Administrator. The Village Council meets on the 2nd Monday of each month.

SCAM ALERT... SCAM ALERT ... The Attorney General sent me an email saying that in 2011 the people of OHIO were scammed out of over \$2,000,000 (TWO MILLION DOLLARS) just in one year. These scams involved "sweepstakes winnings" MY FRIENDS, if it sounds too good to be true.... Then it is!!! If you didn't register for a sweepstakes how can you just randomly be a winner? If they want money up front to release the winnings THEN IT IS A SCAM!!! These are the ones who reported having there money taken from them... how many were too ashamed to admit to being taken.... Don't fall for it. Check it out. Call the Sheriff Dept. and ask. Call the Attorney General's Office. ASK

I have for you in this newsletter the dates for TRASH PICK UP AND RECYCLING. Post this paper on your refrigerator or put it somewhere so you can refer to it. If not, then mark your calendar. This should eliminate a lot of the calls that come into the Office. RECYCLING AND TRASH SHOULD BE SET OUT THE NIGHT BEFORE PICK UP. The Big "O" Refuse hauler we are contracted with is usually in town by 6:00 to begin pickup. Please don't call the Village Office and say they got your neighbor's trash but not yours.... If you didn't set it out the night before. Remember, they pick up in FRONT of your house on the street of your address. This is what our contract says.

Along with this newsletter, you received your water bill. This reflects the water used during the previous three months which includes the holidays. It is not uncommon for your Feb., Mar., and April bills to be higher. It is due to HOLIDAY increased usage. We try to catch unusual fluctuations that might indicate a leak.

THE VILLAGE OFFICES WILL BE CLOSED ON THE FOLLOWING DATES IN 2012 In addition to all Saturdays and Sundays – Jan. 2; Jan. 16; Feb. 20; April 6; May 28; July 4; Sept. 3; Nov.22, 23; Dec. 24, 25; Dec. 31. Please mark these on your calendar.

If your water bill is delinquent, the best thing you can do is call the Village Office and talk to me about "why" it is delinquent. There are good reasons such as layoff, medical, or you just forgot. There are also NOT good reasons (excuses) such as.... Oh...no one says the NOT good reasons. If you are one who is NOT late every month and you have a special circumstance or hardship and need help figuring out how to pay your bill, then call me and we can work something out. I really don't want to shut your water off.

LANDLORDS... we must know when a tenant moves out and the next moves in. You are responsible for the water bill. If you pay it, that's ok but if your tenant is to pay the bill they must fill out an application to have the water turned on and pay the \$100.00 deposit

THE ICE SKATING RINK is up and full of water.... Water... yep water... When it gets cold enough to freeze then you are invited to the park just west of the Village Offices to skate. The Village has a large tub of skates for the Village residents to use if you don't have any of your own. The glowing amber lights from Westerman Inc. gives a wonderful ambiance for skating. Oh, there was two nights back in December when it did freeze and we had some young skaters on the ice. WHEN it gets cold enough to freeze over, call the Village Office to get updates as to the readiness of the ice to skate on. Do not cross the fence or break the yellow caution tape. The ice is not ready unless the tape is removed at the entrance to the skating area.

WHAT IS R.I.T.A. ???

R.I.T.A. is the Regional Income Tax Agency. Beginning December 1, 2011, Bremen became a member. We join 207 other Ohio municipalities.

R.I.T.A. serves as the INCOME TAX collection agency. Each member municipality appoints its own delegate to the Regional Council of Governments (RCOG). Each delegate has one vote on every item that comes before the RCOG, including electing the Officers of the Council of Governments and the R.I.T.A. BOARD OF TRUSTEES. Regardless of the population or tax collections of member municipalities, each member of the RCOG has an equal say in the operations of the Regional Income Tax Agency. Kelley Tripp represents the Village of Bremen.

"The mission of the Regional Income Tax Agency is to provide member communities with high quality, cost effective municipal services. We strive to service member municipalities with integrity and their taxpayers in a professional, courteous, and responsive manner"

R.I.T.A. has recently mailed out tax forms to Village residents and business communities. The Village Offices and local Library have also received a shipment of forms. You may use their E-service applications at www.ritaohio.com where you can register, make a payment, or file and pay your taxes.

Taxpayers may also download a tax form at their website or YOU MAY CALL their Customer Service Dept. at 1-800-860-7482. If you have any questions or need assistance please contact the Member Services Dept. at 1-866-252-0913 or by E-Mail at memberservices@ritaohio.com. Please take this information with you if someone other than yourself does your taxes. They will be familiar with R.I.T.A. and will know what to do. The Village Office will not be as able to answer your questions as R.I.T.A. will.
