#### What's the future of the Internet here?

#### **Discolored Water**

Over the past several months, there have been periodic reports of discolored water coming out of water taps at various residences and businesses in Bremen. It appears the problem is not occurring uniformly across the water distribution system nor with predictable regularity.

There are a number of potential causes for discolored water. In order for the Village to solve the problem, we must receive more accurate and timely reporting from the affected customers.

Therefore, if you experience discolored water, please do the following:


- ✓ Immediately call the village office at 740-569-4788 weekdays. If after hours or on weekends, please call the mayor at 740-569-4897 and report the address, date and time of the occurrence, a description of the water's appearance, etc.
- ✓ Collect a sample of the water in a clean jar and then seal the container. Be sure to write down the date and time of day and from which faucet the sample was collected. Our water department personnel can then come to pick up the sample for their documentation. While they are there, they may also want to look at your indoor pipelines.

With everyone's cooperation in this regard, we intend to determine the cause of the discolored water.

## **Recycling Stats**

Last February, Lancaster-Fairfield Community Action Agency initiated a recycling program for residents of Bremen and Rushcreek Township. The drop off location is currently behind the fire station.

The amount (weight) of materials is measured and the results for 2016 are shown in the following graph. The units of measurement are in pounds.
