Water & Sewer Rate Increase

Over the past year the village has been watching its financial standing in the water and sewer departments. Our infrastructure is crumbling and our departments are losing money from years of neglect and planning. We are extremely lucky to have the staff in place now that is looking to upgrade our systems for the future. The village had a rate study completed to see where we sit and the outcome is that our rates are not where they need to be. Not only is the village struggling financially to sustain our operations at both the water and sewer plants, but we are behind substantially from a funding standpoint. In order for the village to qualify for necessary financial aid in grants we must increase our rates. Enclosed with this newsletter is a snapshot of what the new minimum bill will look like effective January 1, 2020. Please note this will be the new "minimum bill" for service. This rate increase is also matched with a reduction in the water usage. The previous minimum usage was 3,000 gallons per month or 9,000 gallons per quarter. The new minimum usage is 2,500 gallons per month or 7,500 gallons per quarter. The village understands that this is a significant increase; but it must be done in order to move forward and continue the progression for Bremen in the 21st century. This is also a good time to discuss the importance of the U.S. Census which will be completed in 2020. Participating in the Census is a very important responsibility of every Citizen. The Census supports the villages reporting



status which can be a crucial tool in the village applying and receiving federal funding dollars for projects and grants. An invitation to participate in the Census should be sent out on March 12th and it can be completed online this year. This is the first time the census has allowed an online option. Please take the time to participate in the census as it is beneficial to us all!

Leaf Season Pickup Coming to a Close!

Leaf collection will continue beyond December 6th weather permitting. The Street Crew will continue the operation until snowfall makes it impossible to work. The Village asks you to keep putting your leaves in the dog walk and not in the street. Leaves piled in the street create costly repair and maintenance issues.
